

City of Oshkosh Police Department SEX OFFENDER INFORMATION BULLETIN AUTHORIZED BY: CHIEF DEAN SMITH August 29, 2018 BULLETIN #: 2018-05

The Oshkosh Police Department is releasing the following information found on the opposite side of this page pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the <u>potential</u> to offend.

This sex offender <u>has served</u> the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location on the opposite side of this page. <u>THIS PERSON IS NOT WANTED</u> <u>BY THE POLICE AT THIS TIME</u>. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until the passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcements ability to do community notifications. We believe the only person who wins if community notification ends is the sex offender, since the sex offenders derive their power through secrecy.

A community meeting is being scheduled for Tuesday, September 4, 2018 at 6:30PM at the Alumni Welcome Center at UWO located at 625 Pearl Avenue in Oshkosh. The public is invited to attend this meeting. Sex Offender Registration Specialist Heather Dedering will be in attendance to answer your questions. A member from a local counseling service may also be in attendance to present protective behaviors. It is suggested that children not attend due to content.

The Oshkosh Police Department is available to help you set up a Neighborhood Watch and to provide you with useful information on personal safety. If you have information regarding current criminal activity of this or any other sex offender, please call the Oshkosh Police Department at (920) 236-5700. In the case of an emergency, call 911.

The offender was convicted in 2000 of 2ND DEGREE SEXUAL ASSAULT OF A CHILD. The offender sexually assaulted a 13 year old female acquaintance. The offender also unlawfully entered a campus bathroom and stole women's underwear and unlawfully entered the home of an adult female acquaintance and repeatedly stole her underwear. The offender unlawfully entered the home of an adult female stranger.

SPECIAL RESTRICTIONS/REQUIREMENTS:

 NO UNSUPERVISED CONTACT WITH MINORS; NO TAVERNS/BARS/LIQUOR STORES; NO CONTACT WITH VICTIM; NOT TO CONSUME ALCOHOL OR DRUGS.
COMPLY WITH STANDARD SEX OFFENDER RULES; COOPERATE WITH ELECTRONIC MONITORING.
FACE-TO-FACE CONTACT WITH LAW ENFORCEMENT REQUIRED; COMPLY WITH ALL REQUIREMENTS AND LIFETIME REGISTRANT OF WI SEX OFFENDER REGISTRY He will be on Extended Supervision.
