The Oshkosh Police Department is releasing the following information found on the opposite side of this page pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the potential to offend.

This sex offender <u>has served</u> the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location on the opposite side of this page. <u>THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME</u>. THIS NOTIFICATION IS NOT INTEDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until the passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcements ability to do community notifications. We believe the only person who wins if community notification ends is the sex offender, since the sex offenders derive their power through secrecy.

The Oshkosh Police Department is available to help you set up a Neighborhood Watch and to provide you with useful information on personal safety. If you have information regarding current criminal activity of this or any other sex offender, please call the Oshkosh Police Department at (920) 236-5700. The offender was convicted in 2006 of 2nd Degree Sexual Assault of a Child. The victim was a teen female known to him. His targeted victims are minor females and minor males. He used a computer to gain access to the victim's family.

Special conditions of supervision:

- (1) No contact with the victim; No unsupervised contact with minors; No taverns/bars/liquor stores; Not to consume alcohol or drugs
- (2) Comply with standard sex offender rules; cooperate with electronic monitoring.
- (3) Face to face contact with Law Enforcement required; Comply with requirements and Lifetime Registrant of the Wisconsin Sex Offender Registration Program. For more information check www.widocoffenders.org.
- (4) Comply with Discretionary GPS monitoring.

Mr. Petrusch will be living at 141 High Ave Apt A in Oshkosh, WI as of April 4, 2013. He is on active supervision; for more information check www.widocoffenders.org. His agent can be contacted at (920) 424-7745.

As of the date of this bulletin there are 22,547 registered sex offenders in Wisconsin. Of those, 5,854 are in prison. 5,337 are on active probation, parole or extended supervision. 11,356 are terminated from supervision. There are 434 registered sex offenders reporting residence in Winnebago County.
