The Oshkosh Police Department is releasing the following information found on the opposite side of this page pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the potential to offend.

This sex offender has served the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location on the opposite side of this page. THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until the passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcements ability to do community notifications. We believe the only person who wins if community notification ends is the sex offender, since the sex offenders derive their power through secrecy.

The Oshkosh Police Department is available to help you set up a Neighborhood Watch and to provide you with useful information on personal safety. This is a notification regarding the release of Norbert J Maday. On 6/8/94 he was convicted of two counts of 2nd Degree Sexual Assault in Winnebago County. His victims were teenage males and he gained access to them through his position as a priest. Conviction behaviors include; fondling, masturbation, verbal coercion and threats. In 2007 he was released from prison but remained confined pending civil commitment pursuant to Chapter 980/Sexually Violent Person Law. The court has recently determined that Mr. Maday meets the statutory criteria for supervised release under Chapter 980 and ordered his release on or before 8/2/13.

Mr. Maday will reside at 747 Bowen St, Oshkosh WI. He will be under the supervision of the Department of Health Services (DHS) and the Department of Corrections (DOC).

Special Conditions of Norbert Maday's Supervision:

1. Comply with all rules of DHS and DOC sex offender supervision. This includes but is not limited to;
 - a. No contact with victims
 - b. No unsupervised/unauthorized contact with minors
 - c. No presence in taverns, bars or liquor stores. No use of alcohol or illegal drugs.
 - d. May not leave the residence without an approved chaperone for at least the first year.
2. Comply with Lifetime Sex Offender Registration & Lifetime GPS monitoring.

As of the date of this bulletin there are 22,809 registered sex offenders in Wisconsin. Of those, 5,835 are in prison. 5,401 are on active probation, parole or extended supervision. 11,573 are terminated from supervision. There are 439 registered sex offenders reporting residence in Winnebago County.
