### SEX OFFENDER INFORMATION BULLETIN

The Oshkosh Police Department is releasing the following information found on the opposite side of this page pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the potential to offend.

This sex offender has served the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location on the opposite side of this page. THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until the passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcement's ability to do community notifications. We believe the only person who wins if community notification ends is the sex offender, since the sex offenders derive their power through secrecy.

The Oshkosh Police Department is available to help you set up a Neighborhood Watch and to provide you with useful information on personal safety. If you have information regarding current criminal activity of this or any other sex offender, please call the Oshkosh Police Department at (920) 236-5700. In the case of an emergency, call 911.

The offender was convicted in 2005 for 3<sup>rd</sup> Degree Sexual Assault of an adult female acquaintance by force. The court sentenced him to 9 yrs prison followed by 5 yrs extended supervision. The offender has two previous convictions of sexual assault. In 1985, the offender was convicted of 1st Degree Sexual Assault after assaulting a 3 year-old non-relative female who was known to him, and was sentenced by the court to a 4 yr prison term and a consecutive 1 yr jail term. In 1995, the offender was convicted of 2<sup>nd</sup> Degree Sexual Assault of a Child after drugging a 15 year-old non-relative female who was known to him and sexually assaulting her. He was sentenced by the court to a 10 yr prison term.

**SPECIAL CONDITIONS OF SUPERVISION:**

- (1) Comply with standard sex offender rules, including but not limited to: no unsupervised contact with minors; no taverns/bars/liquor stores; no contact with victims; not to consume alcohol or drugs.
- (2) Face to face contact with Law Enforcement required; Lifetime Registrant of the Wisconsin Sex Offender Registration Program.
- (3) Comply with Lifetime GPS monitoring upon release.

Spiering is being released from prison on April 29, 2014 and will be residing 1105 Jefferson St Apt A in Oshkosh. He is on active supervision with the Department of Corrections until 4/30/2019. For more information check [www.widocoffenders.org](http://www.widocoffenders.org)

**Additional sex offender information:**

As of the date of this bulletin there are 23,146 registered sex offenders in Wisconsin. Of those, 5,834 are in prison. 5,454 are on active probation, parole or extended supervision. 11,858 are terminated from supervision. There are 439 registered sex offenders reporting residence in Winnebago County.
