Friday-April 24, 2015

Bomb Threat- 100 block of W. New York Ave.

Merrill Middle School had "there is a bomb" written on a wall at the school. This was prior to school starting and the children were kept away from entering while the school was cleared. No evidence of a bomb was found. Investigation continues as to who wrote the note.

2nd Bomb Threat – 100 W. New York Ave.

A social media message was sent by a student to other students of a bomb at Merrill Middle School. The school was evacuated and the school was cleared. After the investigation was complete, it was learned that a parent of the student had read on Face Book about the original bomb threat and relayed that information to their child; who in turn sent the social media message.

Crash - N. Campbell Ave at Taft Ave.

An 18 year-old male from Oshkosh was injured after he lost control of his motorcycle while driving north on N. Campbell Rd. The male was ejected from his motorcycle and came to rest on the grass shoulder of the road. He was transported to the hospital with non-life threatening injuries to his back and leg.
