He was trapped in his vehicle and had to be extricated by Oshkosh Fire. He was transported to Theda Clark with many injuries, none that appear to be life threatening. A dog that was inside his vehicle did not survive the crash and was turned over to the Oshkosh Area Humane Society. He was also cited for a traffic control violation.
