Monday-June 1, 2015

Juvenile – 400 block of E. Irving Ave.

An 11 year-old male from Oshkosh had referral arrests for disorderly conduct, resisting an officer and discharging bodily fluids at a public safety worker sent to Juvenile Intake after he caused a disturbance in the 400 block of E. Irving Ave. As he was being taken into custody, the juvenile kicked and spit at officers and attempted to bite an officer. He was transported to FDL secure detention by the Winnebago County Sheriff's Office.

Juvenile/Battery to Police Officer – 2800 block of Harrison St.

A 14 year-old female from Menasha, WI had referral arrests for disorderly conduct, battery to a police officer and violation of temporary physical custody sent to Juvenile Intake after she was involved in a physical disturbance in the 2800 block of Harrison St.

The 14 year-old female left the residence after her and an 11 year-old male from Oshkosh were involved in a physical disturbance. Oshkosh Police found the 14 year-old female in the 2500 block of Jackson St. She was transported back to the residence on Harrison St. and ordered to go to her room. She refused and was escorted to her room where she swung a door closed on an Oshkosh Police Officer, breaking one of the officer's fingers. She was taken into custody and transported to FDL secure detention with the assistance of the Winnebago County Sheriff's Office.

In the same incident, the 11 year-old male had a referral arrest for damage to property sent to Juvenile Intake after damage was found to a wall in his room.

The male Oshkosh Officer injured in the incident is a 29 year-veteran. He was treated and released and is on restricted duty.

Theft – 100 block of N. Washburn St.

A 14 year-old male and 10 year-old male, both from Oshkosh, had referral arrests sent to Juvenile Intake for two counts each of retail theft from two previous theft incidents at a store in the 100 block of N. Washburn St. The 14 year-old male was transported to FDL secure detention by the Winnebago County Sheriff's Office. The 10 year-old male was released to a responsible adult.

A 31 year-old from Oshkosh had a referral arrest for theft sent to the Winnebago County District Attorney's Office after it was learned he pawned some of the items stolen by the 14 year-old and 10 year-old males.

Bomb Threat – 300 block of Ohio St.

A bomb threat was called into a business in the 300 block of Ohio St. The business took four phone calls alerting a bomb was going off at about 8:20 PM. The building was cleared and no bomb was found. The investigation continues.

Vehicle Theft Update – Recovered - Inadvertently Towed

The 1994 Dodge Dakota reported stolen had actually been towed from the lot by the property owner for being in disrepair. Owner of vehicle notified.

Warrant – 800 block of W. 20th Ave.

A 47 year-old male from Oshkosh was arrested for a warrant in the 800 block of W. 20th Ave. He was taken to jail.

OWI/Drugged Driving – Division Ave. at Pearl St.

A 26 year-old female from Oshkosh was arrested for 1st offense OWI/Drugged Driving after a traffic stop was made on a vehicle she was driving. She was arrested for 1st offense OWI/Drugged Driving and taken to the hospital for a blood draw. She was released to a responsible adult.

A 23 year-old male from Oshkosh who was a passenger in the vehicle was arrested for bail jumping after he consumed intoxicants, which was in violation of his bond. He was taken to jail.
