The Oshkosh Police Department is releasing the following information found on the opposite side of this page pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the <u>potential</u> to offend.

This sex offender <u>has served</u> the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location on the opposite side of this page. <u>THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME</u>. THIS NOTIFICATION IS NOT INTEDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until the passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcements ability to do community notifications. We believe the only person who wins if community notification ends is the sex offender, since the sex offenders derive their power through secrecy.

The Oshkosh Police Department is available to help you set up a Neighborhood Watch and to provide you with useful information on personal safety. If you have information regarding current criminal activity of this or any other sex offender, please call the Oshkosh Police Department at (920) 236-5700. In the case of an emergency, call 911.

<u>Convictions</u>: In 1993 in Winnebago County Joseph Spaeth was convicted of 1st Degree Sexual Assault of a Child. The victim was a 6 yr old female who was known to him. He was placed on probation, which was later revoked and he was sentenced to 10 yrs prison. This conviction requires lifetime registration. In 1991 in Winnebago County, Joseph Spaeth was convicted of 4th Degree Sexual Assault (2 counts). The victim was a 13 yr old female who was known to him. He was placed on probation, which was revoked and he was sentenced to a term in the county jail. This offense does not require registration.

Other Court Cases: Mr. Spaeth was convicted in another criminal case filed in 2006 (Winnebago County Case # 06CF350) and in 2010 the State of Wisconsin filed proceedings to civilly commit him as a sex offender under Wisconsin Chapter 980 (Winnebago County Case # 10Cl01). However the 2006 criminal conviction was overturned by the Wisconsin Supreme Court in 2012. This contributed to the eventual dismissal of the Chapter 980 civil commitment proceedings in a court ruling on 05/22/15.

<u>Current Status</u>: Due to recent court rulings, Mr. Spaeth's release is required. He is no longer under probation, parole or extended supervision. He has served his entire sentences in the aforementioned convictions. He is required to comply with the Sex Offender Registry for his life and comply with other state statutes that prohibit certain types of contact and/or conduct with children.

Residence: Mr. Spaeth has moved to 521 Monroe Street in Oshkosh.

As of 06/08/15 there are 23,716 registered sex offenders in Wisconsin. Of those, 5,828 are in prison. 5,686 are on active probation, parole or extended supervision. 12,202 are terminated from supervision. There are 470 registered sex offenders reporting residence in Winnebago County.
