#### Wednesday-September 16, 2015

### Child Neglect/Drugs - 300 block of E. New York Ave.

A 45 year-old male from Oshkosh was arrested for child neglect and a probation hold and taken to jail after Winnebago County Social Services requested the assistance of Oshkosh Police in the apprehension of a 13 year-old male who was not attending school.

The 13 year-old was located and taken to shelter care on a hold.

Two females from Oshkosh, a 19 year-old and 18 year-old, were cited for possession of synthetic marijuana and drug paraphernalia and released.

A 45 year-old female was referred to the district attorney's office for child neglect.

A 24 year-old male from Appleton, WI was arrested on a probation hold and taken to jail.

Once she was identified, it was learned that she was missing out of Milwaukee. She was taken to shelter care and was referred to juvenile intake for prostitution and obstructing an officer.
