#### **Friday, September 18, 2015**

##### **Theft/Obstructing/Runaways – 1700 block of Taft Ave.**

A 17 year-old Onalaska male, a 16 year-old Racine male and a 16 year-old Oshkosh female were taken into custody after a theft of a cell phone was reported from a vehicle in the area of Taft Ave. and N. Koeller St.

All three subjects gave false names to officers. Once identified properly, it was learned that all three were runaways from different locations in Wisconsin. The 16 year-old male had a referral arrest sent to Juvenile Intake for theft and obstructing and the 16 year-old female had referral arrests sent to Juvenile Intake for runaway, receiving stolen property and obstructing.

All three were transported to FDL secure detention.

The phone was recovered and returned to the owner.

##### **Welfare Check/Drugged Driving – 1100 block of Waugoo Ave.**

A 42 year-old female from Oshkosh was arrested for 1<sup>st</sup> offense drugged driving after officers were sent to a residence for a welfare check. As officers were checking, the female drove up to the residence where she was arrested. She was released to a responsible adult.

#### **OWI 4<sup>th</sup> Offense/Resisting – Jackson St. at Irving Ave.**

A 34 year-old male from Oshkosh was arrested for 4<sup>th</sup> offense OWI and resisting an officer at Jackson St. and Irving Ave. after he was stopped for not having headlamps on at night. He stopped his vehicle on Jackson St. and Irving Ave. and ran from the vehicle. He was apprehended on Irving Ave. west of Jackson St. He was taken to jail.

#### **Robbery/Theft/Obstructing/Bail Jumping – W. Parkway Ave. at Central St.**

A 34 year-old male from Oshkosh was arrested for obstructing an officer and bail jumping after he initially reported he was a victim of strong armed robbery on W. Parkway Ave. at Mt. Vernon St., which turned out to be a false report.

The 34 year-old initially told police that he had his wallet and money stolen from him by a subject during an altercation at W. Parkway Ave. and Mt. Vernon St. as he was walking home. The wallet that was recovered by the 34 year-old had an ID inside which led officers to a 28 year-old male from Oshkosh.

The 28 year-old male was initially arrested for the strong armed robbery, but the arrest was later amended to theft after the 28 year-old gave his side of the story where he stated it was a drug deal that had gone bad.

The 34 year-old concocted the story and called police after the 28 year-old kept his money.

Both males were taken to jail.
