Friday – February 12, 2016

Attempted Burglary – 200 block of N. Koeller St.

An attempted burglary was reported at a business in the 200 block of N. Koeller St. The investigation continues.

OWI 1st Offense/Warrant – Mill St. and Poplar Ave.

A 31 year-old male from Berlin, WI was arrested for 1st offense OWI at Mill St. and Poplar Ave. after a report of a reckless driver was called into police. The 31 year-old male was taken to jail on a 12 hour-hold.

A 38 year-old male from Princeton, WI who was a passenger in the vehicle was arrested for violating probation. He was taken to jail.

Disturbance – 100 block of E. Gruenwald Ave.

A 31 year-old male from Oshkosh was arrested for disorderly conduct, resisting an officer and possession of drug paraphernalia after the male caused a disturbance inside a business in the 100 block of E. Gruenwald Ave. As officers were investigating the incident, the male refused to listen to officers and resisted arrest. The male was Tased to stop his resistance. During the search, drug paraphernalia was found on the male. He was taken to jail.

Crash/OWI – 1st Offense – Algoma Blvd. at NB Off- Ramp I41.

A 37 year-old female was arrested for 1st offense OWI at Algoma Blvd. at the northbound I41 off-ramp after she failed to stop at the stop sign, crossed the median and crashed into the curb and snow bank in the west bound lanes of Algoma Blvd. She was taken to jail on a 12 hour-hold.
