Friday, May 6, 2016

Weapon – 2300 block of Mt. Vernon St.

A 20 year-old female was arrested for recklessly endangering safety after a disturbance in the 2300 block of Mt. Vernon St. The female used a knife in the incident that caused injury to two males, a 19 year-old and 17 year-old from Appleton, WI. The victims were treated for their wounds. The 20 year-old female was taken to jail.

Drugs – 1800 block of Witzel Ave.

A 35 year-old male from Oshkosh was arrested for intentionally abusing a hazardous substance, obstructing an officer and a probation hold after he was located inside a restroom at a convenience store huffing an aerosol canister. He gave Oshkosh Police a false name when questioned during the investigation. He was taken to jail.

Accident with Injury – 400 block of N. Main St.

A 73 year-old male from Oshkosh was injured as he was walking across the street in the 400 block of N. Main St. The male suffered a head injury that was not life threatening. He was taken by ambulance to a local hospital.

The 21 year-old female driver from Oshkosh was cited for inattentive driving, failure to yield to pedestrian in crosswalk, and failure to have insurance.

N. Main St. was closed for about one-hour.

Disturbance – 2300 block of Mt. Vernon St.

A disturbance was reported in the 2300 block of Mt. Vernon St. The reporting person stated that multiple people were fighting. Upon Oshkosh Police arrival, the group had already dispersed. Once person was questioned and denied there was any disturbance. This may have been in relation to the earlier stabbing incident.

Crash/OWI Causing Injury – Jackson St. at W. Prospect Ave.

A 70 year-old male from Oshkosh was arrested for first offense OWI-Causing Injury after he was driving a vehicle that was involved in a crash at Jackson St. and W. Prospect Ave. The investigation shows the 70 year-old male was south on Jackson St. and attempted to turn east on W. Prospect Ave. in front of a vehicle that was north on Jackson St. He was taken to jail on a 12 hour-hold. The 70 year-old male was also cited for failure to yield right of making a left turn resulting in bodily harm.

The driver and passenger of the other vehicle were taken by ambulance to a local hospital. Their injuries were non-life threatening.

Drugged Driving/Hit and Run – 900 block of W. 18th Ave.

A 39 year-old female from Oshkosh was arrested 1st offense drugged driving after her vehicle struck a curb and parked vehicle in the 900 block of W. 18th Ave. The vehicle left the scene and was located in the 900 block of W. 20th Ave. She was released to a responsible adult.

Disturbance – 1600 block of Doty St.

A 23 year-old male from Oshkosh was arrested for disorderly conduct after he was involved in a verbal disturbance and broke a vehicle window after punching it with his hand. He was taken to the hospital for injuries to his hand and then to jail.

Disturbance – 1300 block of Oregon St.

A 22 year-old female from Omro, WI was arrested for disorderly conduct and resisting an officer after it was reported that she was throwing bar stools and other objects at other patrons and had also physically struck patrons of the business in the 1300 block of Oregon St.

When Oshkosh Police arrived, the female pushed an officer. She was taken into custody and transported to the hospital for medical clearance. She was then taken to jail.
