The Oshkosh Police Department is releasing the following information found on the opposite side of this page pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the potential to offend.

This sex offender has served the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location on the opposite side of this page. **THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.**

Sex offenders have always lived in our communities but it was not until the passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcement's ability to do community notifications. We believe the only person who wins if community notification ends is the sex offender, since the sex offenders derive their power through secrecy.

The Oshkosh Police Department is available to help you set up a Neighborhood Watch and to provide you with useful information on personal safety. The offender was convicted twice in 2008. The first conviction was for 2nd Degree Sexual Assault of a Child after sexually assaulting a 13 year-old male who was known to him and was sleeping. The second conviction was for 2nd degree sexual assault – unconscious victim after sexually assaulting a 19 year-old male who was sleeping. He was also convicted of felony bail jumping for the second offense. He was sentenced to 3 yrs prison and 3 yrs extended supervision for the first conviction of 2nd Degree Sexual Assault. He was then sentenced to 5 yrs in prison and 5 yrs extended supervision for the second conviction of 2nd Degree Sexual Assault. He was sentenced to 1 year in prison and 2 years of extended supervision for the felony bail jumping.

SPECIAL CONDITIONS OF SUPERVISION:

- (1) No unsupervised contact with minors; no taverns/bars/liquor stores; no contact with victims; not to consume alcohol or drugs.**
- (2) Comply with standard sex offender rules.**
- (3) Face to face contact with Law Enforcement required; Comply with all requirements and Lifetime Registrant of the Wisconsin Sex Offender Registration Program.**
- (4) Comply with Lifetime GPS monitoring.**

Blunt will be released to 1105A Jefferson Avenue in Oshkosh, WI on Tuesday, December 27, 2016. He is on active supervision with the Department of Corrections until 5/16/2023. For more information check www.widocoffenders.org

As of 12/8/2016 there are 24,423 registered sex offenders in Wisconsin. Of those, 5,926 are in prison. 5,828 are on active probation, parole or extended supervision. 12,669 are terminated from supervision. There are 487 registered sex offenders reporting residence in Winnebago County.
