The Oshkosh Police Department is releasing the following information found on the opposite side of this page pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the potential to offend.

This sex offender has served the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location on the opposite side of this page. THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until the passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcements ability to do community notifications. We believe the only person who wins if community notification ends is the sex offender, since the sex offenders derive their power through secrecy.

The Oshkosh Police Department is available to help you set up a Neighborhood Watch and to provide you with useful information on personal safety. If you have information regarding current criminal activity of this or any other sex offender, please call the Oshkosh Police Department at (920) 236-5700. In the case of an emergency, call 911.

The offender was convicted in 1999 for 2ND Degree Sexual Assault of a Child for sexually assaulting a 14-year-old female known to him. In a separate incident, the offender was convicted in 2005 of 2ND Degree Sexual Assault of a Child after sexually assaulting a 14 year-old female while threatening the victim with brass knuckles and referenced using a gun.

Special conditions of supervision:

- (1) No unsupervised contact with minors; No taverns/bars/liquor stores; No contact with victim; Not to consume alcohol or drugs.
- (2) Face to face contact with Law Enforcement required;
- (3) Comply with standard sex offender rules; Cooperate with electronic monitoring.
- (4) Comply with requirements and Lifetime Registrant of the Wisconsin Sex Offender Registration Program.
- (5) Comply with Lifetime GPS.

Dodd will be released to 1105A Jefferson St. in Oshkosh, WI on June 6, 2017. He is on active supervision until 9/18/2023. For more information check www.widocoffenders.org.

Additional sex offender information:

As of 05/04/17 there are 24,606 registered sex offenders in Wisconsin. Of those, 5,999 are in prison. 5,764 are on active probation, parole or extended supervision. 12,843 are terminated from supervision. There are 506 registered sex offenders reporting residence in Winnebago County.
