The Oshkosh Police Department is releasing the following information found on the opposite side of this page pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the potential to offend.

This sex offender has served the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location on the opposite side of this page. THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until the passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcement's ability to do community notifications. We believe the only person who wins if community notification ends is the sex offender, since the sex offenders derive their power through secrecy.

The Oshkosh Police Department is available to help you set up a Neighborhood Watch and to provide you with useful information on personal safety. The offender was convicted in 2014 of UNLAWFUL SURVEILLANCE 2ND DEGREE-USE IMAGING DEVICE TO VIEW UNDER CLOTHING and convicted in 2019 of 3 COUNTS of POSSESSION OF CHILD PORNOGRAPHY. The victims were females not known to the offender-aging in range from prepubescent, pubescent and an adult victim.

- 1.) COOPERATE WITH ELECTRONIC MONITORING.
- 2.) LIFETIME REGISTRANT OF WI SEX OFFENDER REGISTRY.

Additional sex offender information:

As of 12/29/25, there are 27,588 registered sex offenders required to register in WI. 6,500 are incarcerated, 6,083 are on active supervision and 15,005 are terminated from supervision. There are 618 registrants in Winnebago County.
