The Oshkosh Police Department is releasing the following information found on the opposite side of this page pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the <u>potential</u> to offend.

This sex offender <u>has served</u> the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location on the opposite side of this page. <u>THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME</u>. THIS NOTIFICATION IS NOT INTEDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until the passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcements ability to do community notifications. We believe the only person who wins if community notification ends is the sex offender, since the sex offenders derive their power through secrecy.

The Oshkosh Police Department is available to help you set up a Neighborhood Watch and to provide you with useful information on personal safety. If you have information regarding current criminal activity of this or any other sex offender, please call the Oshkosh Police Department at (920) 236-5700. In the case of an emergency, call 911.

The offender was convicted in 2000 of 4^{TH} DEGREE SEXUAL ASSAULT and SEX WITH CHILD AGE 16 OR OLDER. He was convicted in 2005 for 2 COUNTS OF 3^{RD} DEGREE SEXUAL ASSAULT and 2 COUNTS OF 4^{TH} DEGREE SEXUAL ASSAULT. He was convicted in 2020 of 3 COUNTS OF 3^{RD} DEGREE SEXUAL ASSAULT. The victims were females known to the offender ranging in the ages of 4-10 years old, 14 years old, 16 years old, 17 years old, and an adult.

SPECIAL RESTRICTIONS/REQUIREMENTS:

- 1.) NO UNSUPERVISED CONTACT WITH MINORS; NO CONTACT WITH VICTIM; NOT TO CONSUME DRUGS.
- 2.) COMPLY WITH STANDARD SEX OFFENDER RULES; COOPERATE WITH ELECTRONIC MONITORING.
- 3.) FACE-TO-FACE CONTACT WITH LAW ENFORCEMENT REQUIRED; COMPLY WITH ALL REQUIREMENTS AND LIFETIME REGISTRANT OF WI SEX OFFENDER REGISTRY.

DANIEL RICHEY will be residing at 215 DIVISION ST in the City of Oshkosh, WI as of DECEMBER 02, 2025. He is on Lifetime GPS. He is on Probation until 12/08/2030. For more information check www.doc.wi.gov

As of 11/14/25, there are 27,542 registered sex offenders required to register in WI. 6,472 are incarcerated, 6,086 are on active supervision and 14,984 are terminated from supervision. There are 620 registrants in Winnebago County.
