Wednesday-September 9, 2015

Child Porn - 400 block of W. 11th Ave.

A 21 year-old male from Oshkosh was arrested at his residence for three counts of exposing genitals to minors; three counts of exposing a child to harmful materials; unlawful use of computerized communication systems; and child enticement after a month long investigation showed the 21 year-old created a fake Face Book account and sent photos of his genitals to female minors. He was taken to jail.

Medical Call - 600 block of Hazel St.

A 20 year-old male from Oshkosh was killed after he fell while cleaning windows in the 600 block of Hazel St. Investigation continues into the incident.

Drugged Driving – Jackson St. at W. Bent Ave.

A 23 year-old male from Oshkosh was arrested for drugged driving, possession of drug paraphernalia and a probation hold at Jackson St. at W. Bent Ave. after his vehicle was observed driving erratically. He was taken to jail.

Thursday, September 10, 2015

Crash/Drugged Driving - Witzel Ave. at Campbell Dr.

Domestic - 600 block of Jefferson St.
