The Oshkosh Police Department is releasing the following information found on the opposite side of this page pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the potential to offend.

This sex offender has served the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location on the opposite side of this page. THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until the passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcements ability to do community notifications. We believe the only person who wins if community notification ends is the sex offender, since the sex offenders derive their power through secrecy.

A community meeting is being scheduled for Thursday, September 24, 2015 at 6 PM in the 1500 block of Ontario St. in the Oshkosh Police Command and Community Operations Vehicle. If the weather is inclement, the meeting will be moved to the Oshkosh Police Department. The public is invited to attend this meeting. Sex Offender Registration Specialist Nichole Hall and REACH Counseling Prevention Education Manager Elizabeth Van Abel will be in attendance to answer your questions.

The Oshkosh Police Department is available to help you set up a Neighborhood Watch and to provide you with useful information on personal safety. If you have information regarding current criminal activity of this or any other sex offender, please call the Oshkosh Police Department at (920) 236-5700. In the case of an emergency, call 911.

The offender was convicted in 2003 for 2nd Degree Sexual Assault for sexually assaulting a 14 year-old female acquaintance.

SPECIAL RESTRICTIONS/REQUIREMENTS:

1. Comply with the Sex Offender Registry for life
2. Subject to GPS monitoring for life
3. Prohibited from working or volunteering with minors under 16
4. Prohibited from photographing, filming or videotaping minors without written permission of parent

Paulsen will be living at 1417 Ontario St. in Oshkosh on a temporary basis until permanent arrangements can be made at an address of 1626 Ontario St. in Oshkosh. Paul Paulsen was released from custody on 9/12/15. He is no longer under any type of probation, parole or extended supervision.

As of 9/17/14 there are 23,868 registered sex offenders in Wisconsin. Of those, 5,810 are in prison. 5,744 are on active probation, parole or extended supervision. 12134 are terminated from supervision. There are 458 registered sex offenders reporting residence in Winnebago County.
